### Public Law

## Reported cases

Re Y (Leave to oppose adoption) [2020] EWCA Civ 1287: Jess was led by Malcolm MacDonald representing the mother in the first remote hearing before the Court of Appeal involving litigants with profound hearing difficulties. The parents had been granted permission to oppose the making of an adoption order, which was appealed by the local authority. The appeal was dismissed. The Court also confirmed that, in the absence of updating guidance from the President in relation to hybrid or remote hearings, the guidance in Re C [2014] EWCA Civ 128 applies.
